## CONDITIONS AND ENTRY REQUIREMENTS:

This race is open to any greyhound whelped in the world between June 1, 2007 and November 30, 2007 that is registered with the National Greyhound Association or other accredited registry that is recognized by the National Greyhound Association of Abilene, Kansas at the time of qualifying. By a nomination fee of \$200 per entry (litter), on or before March 15, 2008; and to remain eligible, \$200 per entry (litter) on or before April 15, 2008; \$300 per entry (litter) on or before May 15, 2008; \$300 per entry (litter) on or before July 15, 2008; \$300 per entry (litter) on or before September 15, 2008; \$300 per entry (each greyhound from a nominated litter) on or before November 15, 2008; and \$400 per entry (each greyhound from a nominated litter) on or before January 15, 2009. A final payment of \$1,000 per remaining entry (each greyhound from a nominated litter) shall be due and payable on or before March 15, 2009 to enter qualifying rounds and must be accompanied by the Registered Name and tattoos of each entry as well as the name of the Registered Owner.

## QUALIFYING RACES

Dates for qualifying rounds and finals will be announced after all nominations and fees are received on March 15, 2009. Qualifying races will generally consist of 8 greyhound fields. Purses for the qualifying races will be paid at the highest grade achieved by any qualifier in each particular qualifying race.

Rounds 1, 2 and 3 will be conducted on a points qualifying basis with the point values being: 16 points for first place, 8 points for second place, 6 points for third place, 4 points for fourth place, 3 points for fifth place, 2 points for sixth place, 1 point for seventh place and 0 points for eighth place.

The 32 greyhounds with the most cumulative points will advance to Rounds 4, 5 & 6. Points from Rounds 1, 2 and 3 will carry over into Rounds 4, 5 and 6. The eight (8) highest point earners after Round 6 will advance to the finals and the second eight (8) will compete in the consolation.

Ties during qualifying rounds will be decided by a) fastest times, b) highest place finisher, and c) by lot.

## PURSE

The original nomination fee, all sustaining and late fees and the qualifying entry fee plus money added by The Woodlands will be distributed as described elsewhere on this entry form. Should a greyhound be found ineligible or be disqualified for any reason, such greyhound will be ineligible for any further purse money and forfeits all fees paid to that point. In the event of a scratch in the finals, the last place purse monies will be divided on a 75%/25% basis between the owner(s) of the scratched entry (receives 75%) and the remainder (25%) added into the total purse. Interest accrued on monies held by The Woodlands for this race will be used for advertising, promotional and administrative expenses. The Woodlands reserves the right to withhold an additional figure not to exceed 3% of all fees (if necessary) for administrative and promotional expenses. The decision of the Board of Judges in all matters shall be final and entries are accepted only on the condition that those persons nominating and/or starting a greyhound in the qualifying rounds and/or the finals agree to abide by their decision.

The Consolation Race Purse will be 7% of the total purse and will be distributed as follows:
